

## **Analysis of the impact of divorce on families and social problems (Case Study: region 2 in Zahedan)**

### **Abstract:**

Divorce is one of the most important phenomena of human life. It is out of the sides, the number of human society, as well as a psychological phenomenon, social, economic and cultural impact on family process takes. In fact you could say the first family values and standards of character and intellectual founding members the family has an important role in determining the fate and life style and policy. The family is a social system that was officially accepted in all developed societies. On the other hand, family disruption or breakdown of the family unit can be used as a break or rupture, making social roles, because of negligence or failure of one or more family members in carrying out their roles may be defined. Divorce and family breakdown is also one of the statistics is still growing in Iran. Zahedan is also not an exception. This study examines the impact of divorce on families and social problems to be addressed in Region 2 in Zahedan. The research method is descriptive, analytical and is based on field studies, library and documents. And for research, data analysis, SPSS software was used. The results of the Spearman's rank correlation coefficient show a positive and significant connection between divorce and social problems of families bought sig 0.000 there. Finally, in line with the recommendations expressed in the research.

### **Introduction:**

Divorce is considered the most important phenomena of human life. This phenomenon has many sides and dimensions of all aspects of human society. First, divorce is a psychological phenomenon, not only because of the psychological balance, but also children, friends, relatives and close friends will affect them. Second divorce economic phenomenon, meaning the family as an economic unit there's also the sense that an economic factor, such as family income and overall poverty, family disorganization is induced. Excluding the divorce phenomenon is affecting all aspects of a community's population, because of the quantity of other works, such as the basic unit of lawful reproduction of the family bursting. Than the other side has an effect on the quality of because - is a community of families, children are deprived of the blessings that are likely ineligible for citizenship in a community office.

Fourth, divorce is a cultural phenomenon, and the other a view of the phenomenon of communication, no connection is thus in a society that is healthy, just and natural. Marriage is no exception. After a divorce, according to a person as a human being and not just from the

perspective of the children, but also from the perspective of society, culture, economy and population one finds (Akbari, 2010, 11). Family as a social unit is the first child of its it deals with the role in the original manufacturer is responsible for the development of children's future character. Family instability caused by this devastating importance is that children are the first victims of these outcomes can be greatly affected by psychological vulnerabilities. One part is destabilizing the foundations of divorced families. Children of divorce, depending on their age and length of deprivation of parental divorce and separated before tension and other factors associated with this axis properties are especially psychologically. Problems, Academic failure, behavior, low self-esteem and interpersonal connection, regardless of gender and age, among children of divorce than non-divorced children have been reported (Amato, 2001).

The role of the family as the smallest social units with different functions, it can be a positive one, the creation of calm and focus on it's negative aspects, the social damage are very important and influential. Among the negative aspects arising from within the institution as divorce injuries that impact the social dimension is extremely high. This work will lead to many social ills. Given that our family has always had a certain richness and strength of personality and social and cultural issues, and the more we focus on the family forms (Timachi, 1997, 6). Divorce in the day, is on the rise and the great social problem in no time like the present, the risk arising from the dissolution of the family circle, and it is not looking. Because if the population goes towards increasing divorce, you are on the brink of crisis. In Iran from 1982 to 1986 of 92 counts of divorces per thousand marriages were registered, and the 7.9 percent, to 10.3 percent is reached in 1997 (Moradzadeh, 2007, 55). Recent statistical information in divorce cases, it represents an increase in statistics. In 2009, one out of every three marriages ended in divorce has risen from 10.3 in 2008 to 13.8 pain is reached in 2009 (Akbari, 2010, 11). So Iran currently considering divorce is ranked fourth in the world (Moshkai and et al. 2011, 36). In fact we can say the divorce with all it's drawbacks, the most important threat is the foundation of the family. And factors that are important. The purpose of this study was to identify assessment of the impact of divorce on families of Region 2 in Zahedan. According to the research question and research theory for this species is:

### **Research questions:**

What is the connection between divorce and family problems and social dimensions are there?

### **The research theory:**

Between divorce and family problems in the social scale, there is a positive and significant connection.

### **Theoretical basic**

#### **Divorce Concept:**

The word divorce means releasing and freeing (Gavahi, 1994, 84) and the term means to destroy a marriage. Break the bond of marriage a specific literal. So, we can break some sort of divorce and separation and disruption of essential foundations of the family. Leading the way for it to be a permanent separation. The law also breaks a marriage annulment or divorce takes place (Mohaghghadamad, 2008, 379). Divorce in ancient societies and religions, to review some of the comments in this regard have been paid. Considering the many sayings and verses in scripture of Zoroastrianism in Persia seems almost unbreakable and break the agreement marriage agreement is simply not possible. In fact, as it exists now in most developed countries it is routine divorce is

an institution subject to the special court was out. In Islam, the Holy Legislator of the possible ways to avoid divorce and its limits. However, it is proved that human desires are not always compatible with each other and perhaps in certain cases, continued marriage is associated with pain and fatigue and this will lead to more corruption. Therefore, though Islam has condemned divorce, but as a last resort, it has issued a license. Divorce causes in general of Iran's rights, including: (1) Divorce Application male, 2 - female divorce request, 3 - Divorce Agreement, each of which is applicable in certain circumstances (Katozian, 1992, 356). Opinions on the topic as divorce include:

### **1 - Crisis of Values**

In societies in transition from social and economic conditions and other terms are specific to the situation, problems arise as a result of collisions between generations modernity and adherence to the traditions of old and intensify the war. At these stage purgatorial sensitive elements, moral and social values more than anything else changing their stance. Many issues unnecessarily yesterday, the acceptable range of modern and contemporary elements of the left leg and most desirable elements of society are outside the realm of social values. This evolution is much faster, conflict and displacement values will be greater. In these conditions the dominant social forces replaced with fresh NIR system of values is undergoing turmoil. Reflecting this situation can be followed in the system of family values. But since the speed was not the same in every culture, with the economic and technical innovations. Generation - who are subject to such rapid social changes, they cannot measure all friendly job sacrifices that have similar values, this condition is caused by family conflict and family disruption and divorce is increasing (Mosavati, 1995).

Bruce Cohen believes it is a fact the divorce rate has increased in modern societies. This situation is changing our society and the values derived from the breakdown and destruction of the family as a social institution. Today, various family functioning has declined in the past couple pick up assets and services and their families rely on. And break it in a conjugal marriage is a disgrace (Cohen, 1991).

### **2. Anomie Theory**

From the perspective of sociology, anomie, lack of consensus on the concept of social goals, social expectations and behavior for members of the community. This led to the gradual disappearance and absence of moral authority and rules and loses its social control society. When society is in transition and transformation, many people are confused way and the rules and values of society, they are trivial and of little value. The new values are consistent with the circumstances, the community still has not happened here. In fact, the two are making. In this community, making some old and some new construction obey (Sarokhani, 1997). Falling apart of norms and anomie, a condition that creates a desire to create is limitless and the limitless nature of these wants cannot be satisfied, when you create to situate social discontent said no social such as divorce, suicide, etc. Appear, which is measurable statistically.

### **History of research**

In this part of the research effort has been made to issues associated with divorce are examined separately.

Ghotbi and et all in 2003 in a paper entitled Factors Effecting the Status of divorce and divorced people living in the area Dawlat Abad, the results have been. Survival test analysis showed there

was a likelihood of divorce after 100 days of marriage, the people who forced marriage as an important factor leading to divorce have mentioned. About 99 percent of the people who did not play a factor in divorce, it was 22 percent. As well as study groups by age, age at divorce, number of children, couples, dating methods (the underlying variable) and forced marriage (the leading cause of divorce) had a significant correlation with the average duration of marriage. More women than men after divorce with his parents and lived alone. Lack of moral understanding (83%) and addiction (42 percent) and family involvement (33%) were the most common causes of divorce. Financial difficulties (30%) and mental illness (24 percent) are the next items.

Sadaralashrafi et al in 2012 in an article entitled Divorce Pathology (the causes) and ways to prevent it, the results are all the factors that affect individual and personality factors such as divorce, economic, cultural, and social and largely on the issue of divorce is effective.

Moshkai et al in 2011 in an article entitled Study Status and Factors Related to Divorce Divorced Couple's Perspective Gonabad City in the years 2007-2008, which were the result of various factors, social, economic, cultural and personal factors associated with divorce most , wife of insufficient knowledge, lack of understanding, involvement of family members and others living, unemployment, forced marriage, lack of life skills, substance abuse, early age of marriage, urbanization, physical or mental illness, lack of communication skills sexual and marriage has been .

Shabani and et al in 2004 in a paper entitled Factors that influence divorce among couples divorce Tabriz came to these results, the difference in Tabriz, the classes and is a meaningful connection divorce's Addiction and The alcoholism and a poor the divorce, there is no significant connection. There is no significant connection between domestic violence and divorce. Class differences as well between the two cities of Tabriz, Sari divorce, there is no difference. Cultural differences and the divorce between the two cities of Tabriz, Sari, there is no difference. To interfere others, and divorce, there is no difference in Tabriz. Between addiction and alcoholism, and divorce is a difference between Tabriz and Surrey. As well as domestic violence and divorce in Tabriz, Sari, there is no difference.

### **Materials and Methods**

The research questions and theories based on objective research, applied research, analytical and descriptive method and based on documents and field studies, library and more. Data collection in this study books and articles written in a divorce is a questionnaire containing 12 questions is. Using questionnaires, interview techniques divorce issues is collected. And SPSS software was used for data analysis. To populate Region 2 in Zahedan in this research is based on the Cochran formula sample of 380 people.

### **Validity and Reliability of research instrument**

Reliability, indicating the instrument in the same terms how the same results can be obtained, the validity coefficients range from zero to one. To determine the reliability of the measurement tool, there are many ways. Among the test retest method, Equivalence method, split half method,

Kuder- Richardson formulas and cronbach alpha method that famous single-factor authentication through a test run, which is provided by cronbach Cornbrash's alpha definition is known. The methods for calculating inner measuring instruments such as questionnaires are used. This tool is available to answer any questions about the different numerical values (Rahimi, 2009: 15). Content validity is based on the validity of the credit. The content validity of a test is usually determined by specialists in the subject. To increase the validity of this study, a questionnaire with a few teachers has been informed and ill-read and expresses their opinions. In this study, the software package SPSS was calculated cronbach's alpha definition. Cronbach's alpha can range between zero and one. The cronbach's alpha reliability of the first to eat more. If cronbach's alpha less than 0.5, the tool lacks reliability. Cornbrash's alpha 0.5 to 0.7 reliability is moderate and acceptable. According to this study (Table 1) questionnaire has acceptable reliability.

### The Situation of the Area under the Study

Zahedan is located in the province of Sistan va Baluchestan in southeast of Iran. It is bordering Afghanistan and Pakistan. Zahedan is the center of the province with an area of 5771 hectares and 2000 meters above the sea level. The area which Zahedan is situated on does not have identical topographical features. Hence, many urban problems are associated with the topographic of the region. Zahedan topographic is mainly influenced by the surrounding mountains and vast plains (Siami, 2006: 78). According to the detailed plan of the city in 1991, Zahedan was divided into 3 regions, 20 district, and 85 localities.

As can be seen in the table and graph above mentioned indices social dimensions, respectively, with a mean index decrease opportunities Marriage 4.00, crime and delinquency, with an average of 3.99, social isolation and disruption of social Identity with an average of 3.90, the social exclusion of families with an average of 3.83, physical and psychological problems among family members with an average of 3.80, lower life satisfaction with an average of 3.78, loneliness among women and men in the family with an average of 3.68, educational problems in children with an average of 3.65, guilt among men and women in families with an average of 3.55, fear of the future among households with an average of 3.45, the problem of duality between family members Average 3.33, creating a step-families with an average of 3.22, respectively, have the highest and lowest ranking.

### Theory testing:

This theory has been drafted as follows:

Significant and positive connection between divorce and social problems of families seen.

To test this theory, given the type of data scale is ordinal, we used the Spearman's rank correlation. For this purpose, we first review and then check out the social indicators, the results are as shown in Table (2) is given. The results of analysis show the social problem of divorce in families affected. These influences have affected most social indicators. In fact, in all the questions given to the sig 0.000 and a positive connection between divorce and social problems of families there.

The results of research using Spearman's rank correlation shows a significant connection between positive and between divorce and social problems of families in all aspects of social problems, including (reduced chances of marriage, crime and delinquency, social isolation and impaired social identity, social exclusion, family members, physical and psychological problems among family members, lower life satisfaction, loneliness among women and men in the family, child-rearing problems, feelings of guilt among women and men in the family, fear of the future among family role ambiguity problem among family members, creating a step-families), obtained with the sig 0.000 there. In fact, we can say that according to information obtained by research theory is proven. And the end is in line with research recommendations:

- ✚ Pervasive culture of dialogue between families.
- ✚ Field of crystallization of talents and abilities, psychological, emotional, social and spiritual family.
- ✚ Develop and strengthen specific services to vulnerable families.
- ✚ Reduce the threat of social control and family businesses in the areas of addiction, unemployment, poverty at the community level.

- ✚ To empower and create employment opportunities and develop insurance protecting the women.
- ✚ Create a culture of divorce among people to reduce the psychological of the injured person.
